- All reproductions are done by the staff of the Detre Library & Archives at their discretion. The Detre Library & Archives reserves the right to deny a request because of an item's fragility, copyright regulations, privacy rights, donor-imposed regulations, or other issues.
- Requests are limited to 200 pages per week from all sources. Requests for larger photocopy requests will considered on a case-by-case basis.

- Requests for rush service will be considered on a case-by-case basis. If rush service can be offered, the total reproduction fee will be doubled.
- Services are rendered on a first come, first served basis. The time required for reproduction requests will vary depending on staff availability.
